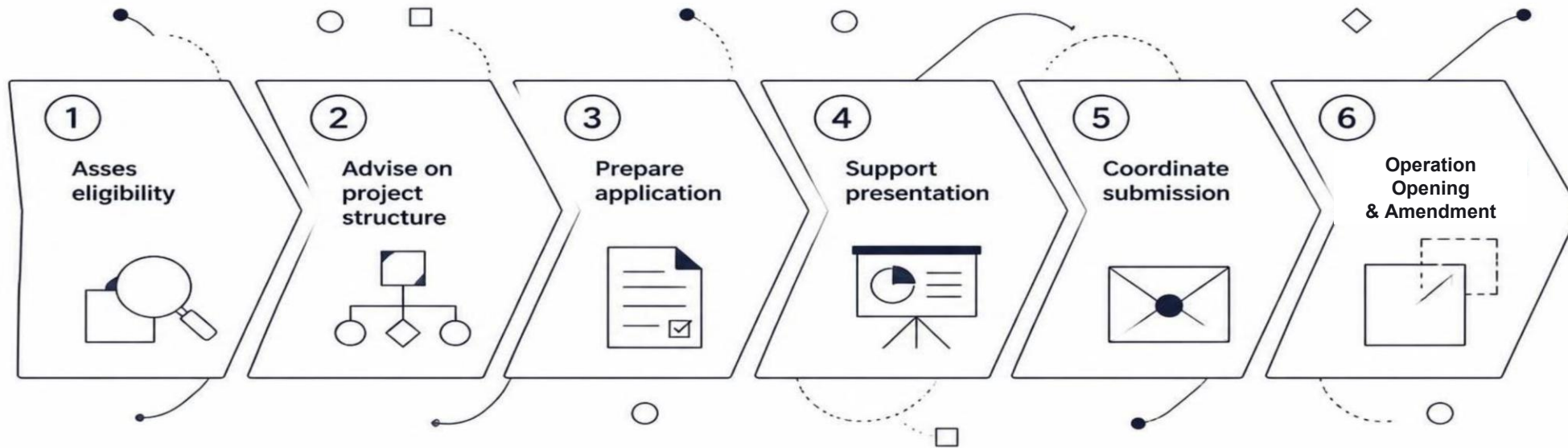

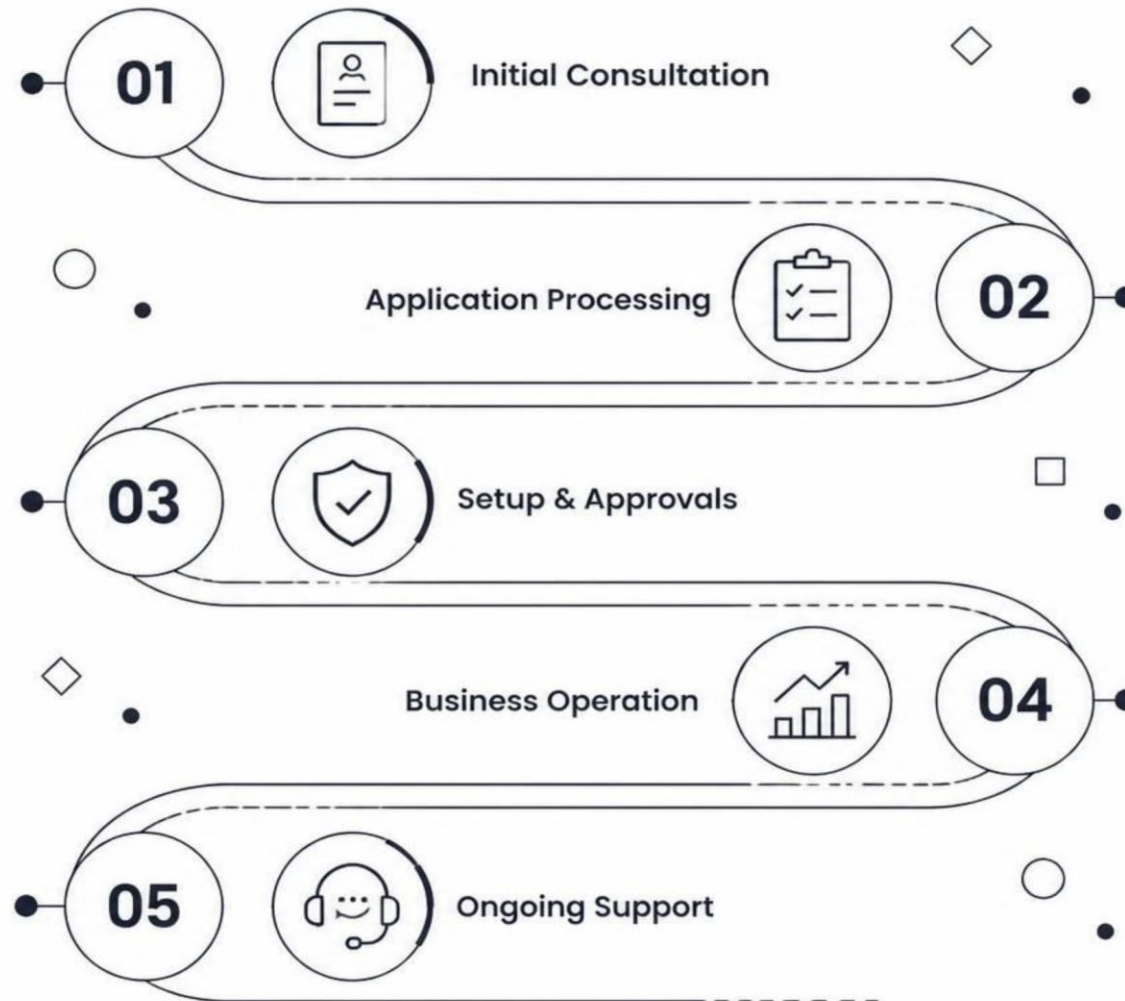

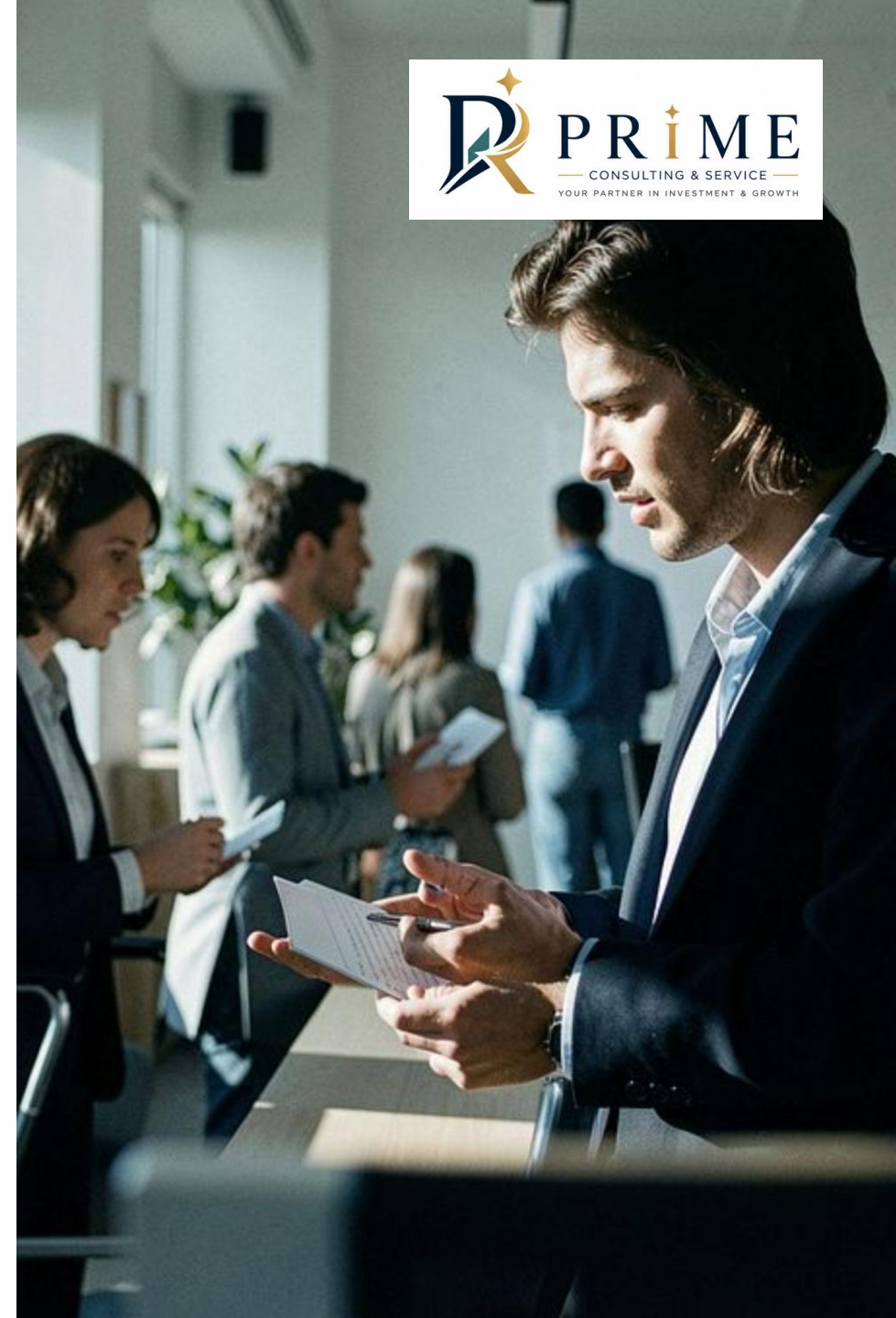

A. BOI INVESTMENT PROMOTION SERVICES

Details of Investment Promotion Services

PRIME provides services from assessing business suitability and project planning, preparing applications and clarifications to BOI, receiving promotion certificates, and post-promotion operations, aiming for clients to utilize privileges appropriately under relevant regulations.

Before Application

- Prepare and review promotion application and supporting documents

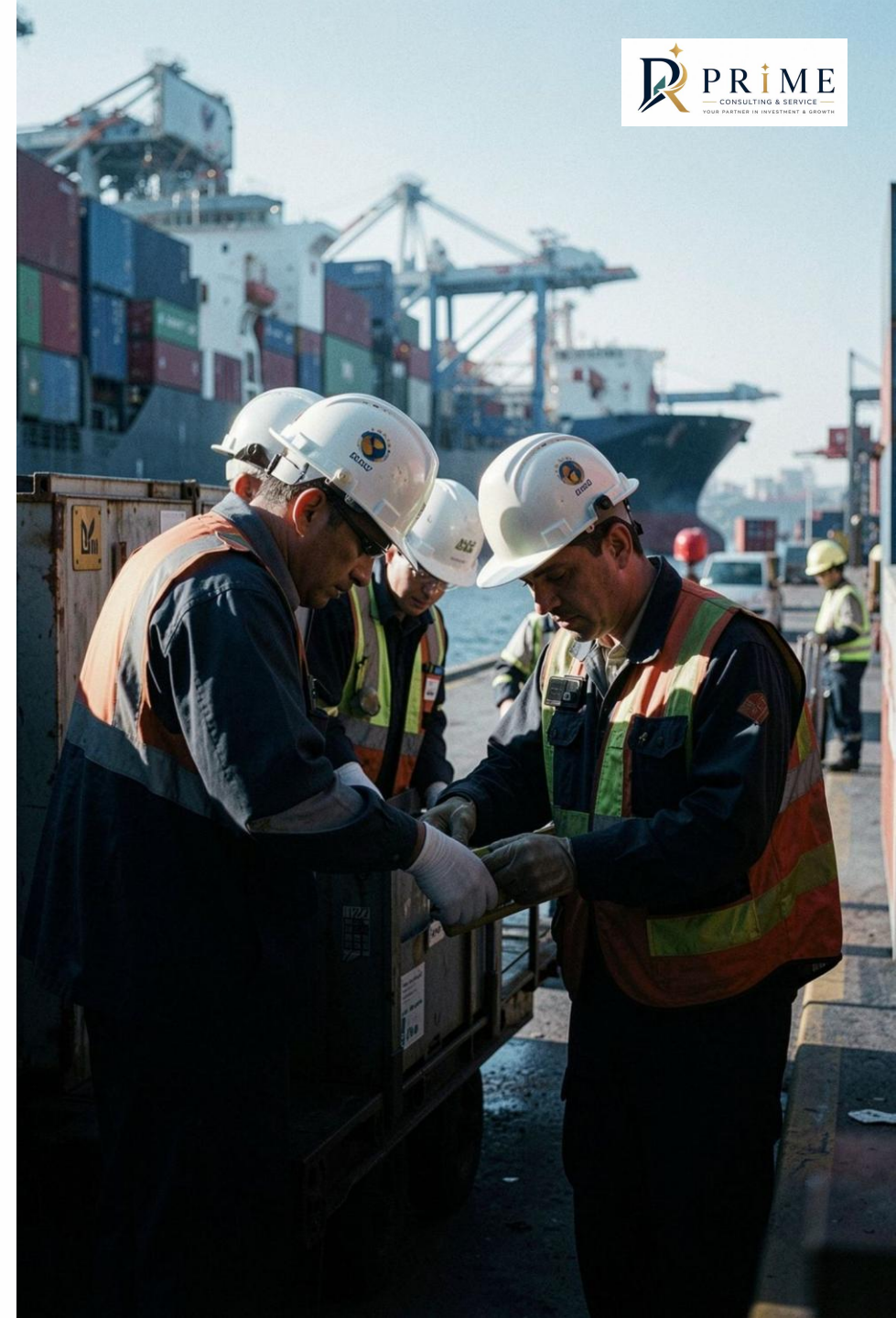
